
STEPHEN T. NIWA, Deputy Prosecuting Attorney for the City and County of Honolulu, State of Hawaii charges as follows:

DECLARATION OF
MICHAEL JAY GREEN

MICHAEL JAY GREEN, declares as follows:

1. I am an attorney for Defendant Owen G. Glenn ("Defendant" and/or "Glenn"), in the above-entitled matter, and am duly licensed to practice before all courts of the State of Hawaii.
2. The matters set forth in this Declaration are based upon my own personal knowledge and information, and are submitted in support of this Motion.
3. On October 7, 2003, Defendant entered a deferred acceptance of no contest plea as to the charge of Assault in the Third Degree - Mutual Affray (§707-712(2), H.R.S.), in the above referenced criminal matter.
4. On or about October 3, 2003, the Court granted Defendant's Motion to Defer and further proceedings were deferred for a period of six (6) months.

5. Under the terms and conditions set forth in the deferred acceptance of no contest plea, Defendant was to refrain from committing another federal or state crime during the deferral period.

6. As of April 29, 2004, Defendant has not been convicted of any crimes.

7. Defendant further requests that the dismissal date be retroactive to April 7, 2004, the date the deferral period expired.
