THREE OF A KIND

The ANZ Commodity Price index posted another sizeable increase, lifting 0.9 percent in September. This represents the third highest level that the index has ever reached, having lifted for a third consecutive month, to be 3 percent away from the all-time high recorded in April. The annual increase in the index remains firm, up 23 percent from a year ago.

Nine commodity prices recorded a lift in September, five prices weakened and three were unchanged in the month.

The international price of wool increased 13 percent in the month, lifting the series to its highest level in eighteen months. The prices of beef, pelts and whole milk powder increased 2 percent in September, with the prices of apples, sheepmeat, casein and cheese rising 1 percent from a month earlier. Sawn timber prices posted a modest lift, inching up a ¼ of a percent – which, while only a modest tick up, represents the series' highest level since October 2007.


Aluminium led the price declines, easing 3 percent in the month and slipping to a four-year low. The prices of butter, logs, skim milk powder and kiwifruit all recorded declines of 1 percent. The prices of seafood, wood pulp and venison were all unchanged.


The value of the New Zealand dollar strengthened across all of our major trading partners in September, with the trade-weighted index of the exchange rate increasing 2.0 percent from August. Once converted into local prices, **the ANZ NZD Commodity Price Index recorded a 1.1 percent decline** in the month of September. The annual increase in the index eased, from 29 percent in August, to 24 percent in September.


