NOTIFICATION OF FAILURE TO MEET CRITICAL KEY PERFORMANCE INDICATOR

I write in relation to the Education Schools Payroll Outsourcing Agreement dated on or about 11 August 2008, between the Ministry, Talent2 NZ Limited (*Supplier*) and Talent2 International Limited (*Guarantor*), as amended from time to time (*Master Agreement*).

Purpose

This letter notifies Talent2 that it has failed to meet Critical Key Performance Indicators (KPIs) in pay periods 12 and 13 of 2012, and that pursuant to clause 13.3 of the Master Agreement the fees payable for each of these pay periods reduces by \$9(2)(b)(ii) OIA

Background

- Under clause 13.3 the Ministry must notify Talent2 before the end of the calendar month following the month in which the relevant failure to meet the Critical KPI is reported to the Ministry by Talent2 if the fee reduction is to occur. Talent2 provided to the Ministry a draft 'KPI Dashboard' on 8 October 2012 but has not otherwise reported against KPIs.
- For the avoidance of doubt, the Ministry does not consider that the 'KPI Dashboard' meets Talent2's reporting obligations.

KPIs Breached

The table below sets out the details of the Critical KPIs that Talent2 has failed to meet and the pay period in which that failure occurred.

In this letter, references to the Master Agreement include a reference to its Schedules and Service Schedules. Terms defined in the Master Agreement have the same meanings when used in this letter, including the appendices of this letter. Unless the context requires otherwise, a reference in this letter to an Appendix is a reference to an appendix of this letter.
